2024 California Immunization Coalition Summit Exhibit and Sponsorship Agreement

RULES, REGULATIONS, AND LIABILITY INDEMNIFICATION

Each Exhibitor at the 2024 California Immunization Coalition Summit shall agree to each of the following terms and conditions:

- O1. California Immunization Coalition (CIC) reserves the right to decline, prohibit, deny access to, or remove any exhibit which in its sole judgment is contrary to the character, objectives, and best interest of the Summit or suitable for its attendee audience. This reservation includes, but is not limited to, any violation of any public policy, or these rules and regulations and extends to persons, things, printed matter, products, and conduct. CIC reserves the right to refuse applications of Exhibitors not meeting standards required or expected, as well as the right to curtail exhibits or parts of exhibits that contravene the character of the meeting.
- **02**. Upon receipt of an exhibit table application, CIC will notify the exhibitor with confirmation and send separate instructions explaining how to register and submit additional information.
- 03. Nothing shall be posted on, nailed, screwed, or otherwise attached to columns, walls, floors, drapes, or other parts of the building in accordance with the rules of the Safe Credit Union Convention Center.
- **04.** Exhibitor agrees not to dismantle its booth and not to conduct any packing before the move-out period.
- 05. There is no security personnel provided. The exhibitors should not leave valuable articles unprotected. "Handouts" or gifts should be placed out of sight or locked during non-Summit hours.
- 06. Exhibitors will receive a full refund, less a service charge of \$200.00, if the Exhibitor submits written notice of cancellation to CIC on or before February 28, 2024. No refunds will be given for any cancellation notification received after February 28, 2024.
- 07. Neither CIC or the Safe Credit Union Convention Center maintain insurance to cover the exhibitor's property. Damage or loss, as well as injury to person(s) assembling or dismantling any exhibit, is the sole responsibility of the exhibitor.
- 08. Summit organizers reserve the right to assign exhibitors to their space. Every effort will be made to accommodate the exhibitor's location preference. Prior notification will be given to the exhibitor in order to mutually agree on a different location within the exhibit area.

- **09.** The sponsor agrees to use the Summit attendee listing for the purposes of invitations to exhibit or attend hospitality functions only. This listing may not be used for mass marketing purposes.
- 10. Demonstration/AV Equipment All demonstrations shall be confined to the space allotted to each exhibitor. Activities should be planned in such a manner that they will not interfere with the normal traffic flow, nor infringe on normal conversations in the nearby exhibits. Any exhibit consistently disturbing other exhibitors may be closed.
- 11. Should the Summit venue experience damage or destruction by strikes, Acts of God, a national or state emergency declaration, or other causes beyond the control of CIC, so as to prevent CIC from exhibit hours, the exhibitor will be charged for space only for the period the space was or could have been occupied by exhibitor; and the exhibitor hereby waives any claim against CIC, directors, officers, agents, or employees for losses or damages which may arise in consequence of such inability to occupy assigned space.
- 12. Exhibitor agrees to defend, indemnify, protect, save and hold harmless CIC, the Safe Credit Union Convention Center, and all of its or their agents or employees from and against any claim, loss, liability, damages or charges imposed against any indemnitee based on all of the following: (a) violations of any ordinance; (b) Exhibitor's construction or maintenance of an unsafe exhibit; (c) the negligence or misconduct of Exhibitor or its agents or Exhibitor's breach of any of the terms and conditions under this Agreement; and (d) all other claims, demands, losses, costs, and damages, including attorneys' fees, court costs and judgments, arising from or relating in any manner to Exhibitor's, its agents, employees, and business invitees occupancy and use of the exhibition premises, or any other part of the hotel. Exhibitor must maintain proper insurance coverage for its property and liability.
- **13.** Exhibitor intends to be legally bound by the terms of this Agreement
